

# 深圳城市形象标识全球征集设计应征承诺书

## Global Solicitation for Shenzhen City Logo Design: Commitment Letter of Applicants

承诺人已充分知晓并自愿接受《深圳城市形象标识全球征集规则》(以下简称“《征集规则》”),  
谨向主办者承诺如下:

1. 承诺人保证除主办方及指定的内部工作机构外,不得对外披露应征方案本身及其创意。
2. 承诺人保证作品为原创,拥有完整、排他的著作权,除参加本征集活动外,未曾以任何形式公开发表。
3. 承诺人保证,作品自成为城市形象标识,一切知识产权(包括但不限于著作权,对作品的一切平面、立体或电子载体的全部权利)归主办方所有。主办方有权对成为城标的作品进行任何形式的使用、开发、修改、授权、许可或保护等活动。
4. 承诺人保证其应征作品不得侵犯他人的合法权益,否则,由承诺人自行承担相应法律责任。  
如因承诺人违反本规定,致使主办方遭受任何损失,主办方有权要求其赔偿。最终解释权归属于主办方。
5. 本承诺书自承诺人签字(或盖章)之日起生效。

The promisee (Signatory hereunder) is making the commitment hereinafter on the basis of being fully aware of and willingly accepting "the Rules of Global Solicitation for Shenzhen City Logo Design" (Hereinafter referred to as the Solicitation Rules) :

1. The promisee shall not disclose the bidding work and its originality to any third party (except the Organizer and the appointed internal organizations) in any form.
2. The promisee is committed to being the creator of the bidding work and having its complete and exclusive copyright. The bidding work has not yet been published in any form, except this solicitation.
3. The promisee agrees that once the bidding work is chosen as Shenzhen' s city logo, all the intellectual properties (including but not limited to the copyright, any and all rights in all the planes, solid or electronic carriers) shall remain the property of the Organizer. The Organizer reserves the right to use, exploit, revise, authorize, license or protect the bidding work in any form.
4. The promisee is committed that the bidding work does not infringe the legal interests of any third party. Otherwise, the promisee shall be responsible for all legal consequences of infringement. The Organizer reserves the rights to pursue the liabilities of the promisee if there is any loss caused to the Organizer because of the promisee' s infringement. The Organizer also reserves the rights for the interpretation of the infringement.
5. The commitment letter comes into effect since the day the promisee signs his or her name (or stamp his or her seal.)
